Regulation Number 139/2022
A Regulation to Provide for the Amendment for the Suspension of Residential Housing Rental Increment for 90 days

WHEREAS, the housing rental price has been increasing unfairly by landlords beyond the reasonable rental price on tenants, the request of unfair rental price, the inappropriate eviction of tenants based on the interest of the landlord, and the existence of conflict between tenants and landlords have created exasperation on the residents of the city and such has caused sufferings and intense dissatisfaction of the public; and therefore, it has been found necessary to temporarily suspend the residential housing rental increment until addressing the problem;

NOW, THEREFORE, in accordance with Article 92 of the Addis Ababa City Government Executive Organs Establishment and to specify the Power and Duties of the thereof Proclamation No. 74/2021, the Cabinet of the Addis Ababa City government has issued this amendment Regulation.

1. Short Title

This Regulation may be cited as: “An Amendment for Regulation No. 123/2021 issued for the amendment of Suspension of Residential Housing Rental Increment for 90 days Regulation No. 139/2022.”

2. Amendment

Regulation No. 123/2021 that was issued for the amendment of suspension of residential housing rental increment for 90 days is hereby amended as follows.

1. Sub-Article (1) of Article 4 of the Regulation is cancelled and replaced by the following Sub-Article:

4. About Suspension

“1. without prejudice to the provisions of other laws, a rental increment on residential houses from August 25th, 2022 to February 24th, 2023 is prohibited.
