A Regulation to Provide for the Amendment for the Suspension of Residential Housing Rental Increment for 90 days

WHEREAS, the housing rental price has been increasing unfairly by landlords beyond the reasonable rental price on tenants, the request of unfair rental price, the inappropriate eviction of tenants based on the interest of the landlord, and the existence of conflict between tenants and landlords have created exasperation on the residents of the city and such has caused sufferings and intense dissatisfaction of the public; and therefore, it has been found necessary to temporarily suspend the residential housing rental increment until addressing the problem;

NOW, THEREFORE, in accordance with Article 92 of the Addis Ababa City Government Executive Organs Establishment and to specify Power and Duties of the Proclamation No. 74/2021, the Cabinet of the Addis Ababa City government has issued this amendment Regulation.

1. Short Title

This Regulation may be cited as: "An Amendment for Regulation 122/2021 issued for the Suspension of **Residential Housing Rental Increment** for 90 days Regulation No. 123/2022."

2. Amendment

Regulation No. 122/2021 that was issued for the suspension of residential housing rental increment for 90 days is hereby amended as follows.

1. Sub-Article (1) and (2) of Article 4 of the Regulation is cancelled and replaced by the following Sub-Article:

4. About Suspension

- "1. without prejudice to the provisions of other laws, a rental increment on residential houses from February 25th, 2022 to August 24th, 2022 is prohibited.
 - 2. notwithstanding to Sub-Article (1) of this Article, if the suspension is found necessary, it shall be extended by the Mayor."

- 2. The following new Sub-Article (5) is added following Sub-Article (4) of Article 6 of the Regulation:
- "5. Notwithstanding the provisions of Sub-Article (4) of Article 6 of the Regulation and Article 1 of the amendment Regulation, a request for eviction and rental increment due to compelling and various situations may be approved upon the submittal of the thereof, in writing with substantial evidence, to the Mayor."

3. Effective Date

This Regulation shall enter into force as of this 26st day of March 2022.
