PROCLAMATION NO. 696/2010.

**A PROCLAMATION TO RATIFY THE CREDIT
AGREEMENT BETWEEN THE GOVERNMENT
OF THE FEDERAL DEMOCRATIC REPUBLIC
OF ETHIOPIA AND THE EXPORT-IMPORT
BANK OF CHINA**

WHEREAS a Credit Agreement, between the Government of the Federal Democratic Republic of Ethiopia and the Export Import Bank of China stipulating that the Export Import Bank of China provide to the Federal Democratic Republic of Ethiopia a credit amounting to 99,450,000 USD (ninety nine million four hundred fifty thousand United States Dollars) for financing the Adama/Nazareth Wind Power Construction Project was signed on the 23rd day of November 2010;

WHEREAS the House of Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified the Agreement at its session held on the 21st day of December 2010;

NOW, THEREFORE, in accordance with Article 55(1) and (12) of the Constitution of the Federal Democratic Republic of Ethiopia, it is hereby proclaimed as follows:

1. Short Title

This Proclamation may be cited as the "Export Import Bank of China Credit Agreement to Provide Loan for Financing the Adama/Nazareth Wind Power Construction Project Ratification Proclamation No. 696/2010".

2. Ratification of the Agreement

The Loan Agreement signed on the 23rd day of November, 2010, between the Government of the Federal Democratic Republic of Ethiopia and the Export-Import Bank of China is hereby ratified.

3. Power of the Ministry of Finance and Economic Development

The Ministry of Finance and Economic Development is hereby empowered to undertake all acts necessary for the utilization of the loan amount of 99,450,000 USD (ninety nine million four hundred fifty thousand United States Dollars) in accordance with the terms and conditions set forth in the Loan Agreement.

4. Effective Date.

This Proclamation shall enter into force up on the date of publication in the Federal Negarit Gazeta.

Done at Addis Ababa, this 30th day of December, 2010
