PROCLAMATION No. 709/2011.

**A PROCLAMATION TO RATIFY THE TRIPARTITE
CONSULTATION (INTERNATIONAL LABOUR
STANDARDS) CONVENTION**

WHEREAS, the General Conference of the International Labour Organization adopted the Tripartite Consultation (International Labour Standards) Convention No. 144/1976 on the 21st day of June 1976 during its Sixty First Session held at Geneva;

WHEREAS, the House of Peoples' Representatives of the Federal Democratic Republic of Ethiopia has ratified said Convention at its session held on the 28th day of April, 2011;

NOW, THEREFORE, in accordance with Article 55 (1) and (12) of the Constitution of the Federal Democratic Republic of Ethiopia, it is hereby proclaimed as follows:

1. Short Title

This Proclamation may be cited as the " Tripartite Consultation (International Labour Standards) Convention No. 144/1976 Ratification Proclamation No. 709/2011".

2. Ratification of the Convention

The Tripartite Consultation (International Labour Standards) Convention No. 144/1976 adopted by the General Conference of the International Labour Organization on the 21st day of June, 1976 during its 61st Session held at Geneva, is hereby ratified.

This Proclamation shall enter into force up on the date of publication in the Federal Negarit Gazeta.
