Whereas, it is found necessary to establish bureau Of Livestock And Pastoralists Development to speed up the development of livestock and Pastoralists Development sector ;

NOW, THEREFORE, in accordance with Article 49(3, A) of the Revised Constitution of the Somali Regional State of Ethiopia, the council of the regional state hereby proclaimed as follows:

PART ONE
GENERALITY

1. **Short Title**

This Proclamation may be cited as the “Establishment Proclamation of Livestock and Pastoralists Development Bureau of the Somali Regional State of Ethiopia, Proclamation No. 155 /2016”

2:- **Definitions**

Unless the context requires otherwise in this proclamation:-

1. **“Xoolo”** waxa loola jeedaa dhammaan noocyada kala duwan ee xoolaha nool.
2. **“Xafiis”** waxaa loola jeedaa Xafiiska Horumarinta Xoolaha iyo Reer guuraaga ee Dawladda Deegaanka Soomaalida Itoobiya ee lagu aasaasay bayaankan.
3. **“Deegaan”** waxaa loola jeedaa deegaanka soomaalida Itoobiya ee lagu aasaasay Qodobka 47^{aad} ee Dastuurka Jamhuuriyadda Dimoqraadiga federaalka Itoobiya.

Qodobka..3^{aad} **Aasaasida iyo Cidda Xafiisku hoos tagayo**

1. Waxaa bayaankan lagu aasaasay Xafiiska Xoolaha iyo Horumarinta Reer Guuraaga ee Dawladda Deegaanka Soomaalida Itoobiya oo wixii hada ka dambeeya loogu yeedhi doono **“Xafiis”**, ahna hay’ad dawli oo iskeed u madax bannaan islamarkaana leh jiritaan sharciyeed.
2. Xafiisku wuxuu hoostagaya Golaha hawl fulinta iyo Madaxweynaha Deegaanka.

2. Xarunta Xafiisku waa magaalada Jig-jiga, haddana wuxuu gobolada iyo degmooyinka ku yelan karaan laamo hadba sida baahidu tahay.

2. የቢሮው ተጠሪነት ለክልሉ አስፈፃሚ ምክር ቤትና ለክልሉ ፕሬዝዳንት ይሆናል፡፡

4. ስለቢሮው አቋም

1. ቢሮው:-
 - ሀ) በፕሬዝዳንቱ አቅራቢነት በአስፈጻሚ ምክር ቤት የሚሾም አንድ ቢሮ ኃላፊና ምክትል ቢሮ ኃላፊ ይኖሩታል፤
 - ለ) ለሥራው አስፈላጊ የሆኑትን የሥራ ሂደቶችና ሌሎች ሠራተኞች ይኖሩታል፡፡
2. የቢሮው ዋና መስሪያ ቤት ጅግጅጋ ከተማ ውስጥ ሆኖ እንደአስፈላጊነቱ በዞኖችና በወረዳዎች ቅርንጫፍ ጽ/ቤት ሊከፍት ይችላል፡፡

5. የቢሮው ዓላማዎች

1. የእንሳስትና የእንሳስት ተዎኦ ልማት የሚድብርበት ሥርዓት በማዘርጋት የህብርተስቡን የእንሳስትና የእንሳስት ተዎኦ ልማትና ማርቢያ ዘዴዎች እንዲጎላብት ጥራት ማድርግ ነው፡፡

1. **“Livestock”** Means the various types of domestic animals.
2. **“Bureau”** Means the Livestock and Pastoralists Development Bureau of Somali Regional State of Ethiopia established hereof.
3. **“Region”** “means the Somali regional state of Ethiopia established under Article 47 of the constitution of Constitution of the Federal Democratic Republic of Ethiopia.

3:- Establishment and Accountability of the Bureau

1. The Livestock and Pastoralists Development Bureau of Somali Regional State of Ethiopia Ethiopian Herein after referred as” **Bureau”** is hereby established as an autonomous Government Body having its legal personality,.
2. The Bureau shall be accountable to the executive council and President of the Region.

4:- Organizational setup of the Bureau

1. The Bureau shall have:
 - A. Bureau head and Deputy Bureau head appointed by the executive council upon the recommendation by the President.
 - B. Core processes and other necessary staffs.
2. The head quarter of the Bureau shall be in Jig-jiga, however it may have offices, in Zones and Woredas of the region as may be necessary.

5 :- Objectives of The Bureau

1. To establish a modern system for the promotion of development livestock and its productivity thereby envisaged modes of livestock husbandry/ rearing and utilization of their resources.

7. የክልሉ አርብቶ አደር ማህብርሰብ በተለያዩ የቴክኒክና ሙያ ስልጣናዎች ተጠቀሚ እንዲሆኑ በክልሉ ውስጥ ፋጣንና ቀጣይናት ያለው የእንሳስትና የአርብቶ አድሩ ልማት አውታሮዎች እንድስፈሩ ያደርጋል፤፤
8. አግባብ ካላቸው አካላት ጋር በመተባበር በክልሉ ውስጥ ስለዲር አራዊት ጥበቃና አጠቃቀም ህጎች በማመንጨት አፈፀፀማቸውን ይካታተላል፤

2. To exploit animal production and productivity efficiently and improve the live hood of rural community.

PART THREE

6. Powers and Duties of the Bureau

The Bureau shall have the following powers and duties:-

1. Initiate, design and implement policies and programs that could improve the live hood of pastoral community of the Region.
2. Introduce sustainable pastoral community development provisions in the Region.
3. Study constraints of pastoral and rural community developments and devote alleviating techniques.
4. Build and support woreda Administrations in training in various professional of technology in a view with achieving efficient pastoralist development programs in the Region.
5. Support districts Administration to achieve integrated sustainable development.
6. Create the availability marketing system for livestock and its products.
7. Introduce sustainable development of pastoralist development provisions and rural community in the Region and to train in various professional technologies.
8. In cooperation with the concerned organs designs laws on the protection and conversation wildlife in the Region and follow up it's implementation.

- 11. Wuxuu dhisaa islamarkaana maamulaa Xarumaha tababarda dhaqashada iyo xananeynta xoolaha ee xoolo dhaqatada.
- 12. Wuxuu qaabta shaqooyinka ilaalinta duur-joogta degaanka.
- 13. Wuxuu darsaa, uruuriyo islamarkaana xafidaa xogaha iyo tirakoobta xoolaha nool ee deegaanka
- 14. Wuxuu isagoo la kaashanaya qaybaha ay khusayso abuura qaab bulshada xool-dhaqaatada iyo xool dhaqaatada beeralayada iskugu jirta loogu diyaarin lahaa adeegyada daymaha
- 15. Wuxuu tageerada ku habboon u fidiyaa dhismaha iskaashatooyinka xoola-dhaqaatada.
- 16. Wuxuu darsaa islamarkaana horumariyaa dhaqashada iyo badinta tafirta casriga ee xoolaha nool.
- 17. Wuxuu qadaa talaabooyin lagaga hortagayo laguna xakameeynayo cudurada xoolaha.
- 18. Waa mulkiile hanti, wuxuu galaa heshiisyo waxaana lagu dacweyn karaa waxna uu ku dacweyn karaa magaciisa.

7. የቢሮው ኃላፊ ሥልጣንና ተግባራት

- 9. Conduct quarantine controls on animals and animal products brought into or taken out of the region based on the national livestock development policy;
- 10. Establish and direct centers for animal health and animal husbandry in the Region.
- 11. Establish and direct training centers assisting the development and improvement of animal's resource of pastoralists.
- 12. Undertakes Duties Conservation of wildlife In the Region.
- 13. Study, Collect and compile the statically data showing the livestock resource in the Region.
- 14. in cooperation with the concerned organs, 'facilitate the provision of credit facilities to agro- pastoralists and pastoralists;
- 15. Provides support the formulation and establishment of pastoralist associations.
- 16. Performs Studies for enhancing of animal husbandry and breeding of special species.
- 17. Take the necessary measures to prevent the outbreak of animal diseases.
- 18. own property, enter into contracts, sue and be sued in its own name;

7. Powers and Duties of the Bureau Head

In addition to the powers and duties of the bureau provided under Article 6 of this Proclamation, the bureau head shall have:-

The rights and obligations of bureau Agriculture and livestock Development under the proclamation No 64/2008, to provide the establishment and pronounce the powers and duties of executive organs as regards provisions dealing on livestock and pastoralists Development are hereby transferred to the livestock and pastoralists Development Bureau.
