GENERAL PROVISIONS

1. Ciwaan Gaaban

Bayaankan waxaa loogu yeedhi karaa “**Bayaanka dib loo Habeeyay ee Aasaasida, Awoodaha iyo Waajibaadka Magaalooyinka Dawlada Deegaanka Soomaalida, bayaan tirsi 198/2012.**”

2. Qeexid

Bayaankan dhaxdiisa si aan haboonaanta eraygu macno kale u siinin.

1. **“Magaalo”** waxaa loola jeedaa noocyada iyo heerarka magaalo ee ku cad qodobka 5^{aad} ee bayaankan.
2. **“Golaha magaalada”** waxaa loola jeeda golaha lagu dhisay hab waafaqsan qodobka 22^{aad} ee bayaankan.
3. **“Maxkamada heer Degmo”** waxaa loola jeedaa maxkamada lagu aasaasay Qodobka 57^{aad} ee bayaankan.
4. **“Dastuurka”** waxaa loola jeedaa dastuurka dib loo habeeyay ee dawaladda Deegaanka Soomaalida.
5. **“Aqoonsi”** waxaa loola jeedaa hanaanka bulshada ku nool aag lagu siinayo aqoonsi magaaloniimo si waafaqsan qodobka 5^{aad} ee bayaankan.
6. **“Duqa maamulka magaalo”** waxaa loola jeedaa masuulka fulineed ee ugu sareeya maamulka magaalada ee u golaha magaaladu ku soo magacaabo hab waafaqsan qodobka 21(1) ee bayaankan.
7. **“Maareyaha adeegyada”** waxaa loola jeedaa maareyaha lagu magacaabay raali ahanshaha golaha sida waafaqsan qodobka 13^{aad} qodob hoosaadyadiisa 1(j) iyo 2(t) ee Bayaankan si uu u maareeyo adeegyada dawalda hoose ee magaalada.
8. **“Ururka Magaalooyinka”** waxaa loola jeedaa ururka ay magaaloooyinku u aasaastaan hab waafaqsan Qodobka 62^{aad} ee Bayaankan.

5. **“ፈርጅ”** ማለት በዚህ አዋጅ አንቀጽ 5 መሠረት ከተሞች የደረሱበትን የእድገት ደረጃ በመመዘን የከተማነት ደረጃ እውቅና የሚሰጣቸው አካባቢ ነው፤
6. **“ከገዢ”** ማለት በዚህ አዋጅ አንቀጽ 21(1) መሠረት በከተማ ምክር ቤት አማካኝነት የሚመረጥ ሆኖ የከተማውን የፖለቲካ፣ የአስተዳደር፣ የልማትና የአገልግሎት አሰጣጥ ሥራዎች በበላይነት የሚመራና የሚያስተባብር ዋና ሥራ አስፈጻሚ ነው፤
7. **“ሥራ አስኪያጅ”** ማለት በዚህ አዋጅ አንቀጽ 13(1,ሐ)ና (2 ለ) መሠረት በምክር ቤቱ ፊቃድ የሚሾም የከተማ ማዘጋጃ-ቤታዊ አገልግሎቶችን የሚያከናውን ኃላፊ ነው፤
8. **«የከተማ ማህበር»** ማለት በዚህ አዋጅ አንቀጽ 62 መሠረት ህጋዊ ሰውነት ያላቸው ከተሞች አንድ ላይ በመቀናጀት ለጋራ ልማታቸው ጥቅም ሲሉ የሚመሰርቷቸው ማህበራት ማለት ነው።

1. Short Title

This proclamation may be cited as “**The Revised Somali Regional State Urban Centers Re-Establishment, Organization and Determination of their Powers and Duties Proclamation No. 198/2020**”

2. Definitions

Unless the context requires otherwise, in this proclamation:

1. **“Urban”** means any area and categories of urban centers as prescribed under Article 5 of this proclamation;
2. **“Urban Council”** means a body elected by people or designated as per Article 22 of this proclamation;
3. **“Wereda Court”** means the ordinary judicial body established under Article 57 of this proclamation;
4. **“Constitution”** means The Revised Somali Regional State Constitution.
5. **“Category”** means the level of urbaneness rendered for urban in accordance with political, economic and social development activities as per the criteria laid down under article 5 of this proclamation;
6. **“Mayor of the City Administration”** means the chief executive officer, elected by the city council in accordance with Article 21(1) of this proclamation;
7. **“City Manager”** means an official who executes the municipal services of the city administration nominated with the consent of the council pursuant with Sub-article 1(c) and sub-article 2(b) of article 13 of this proclamation;
8. **“City Associations”** means associations established by the cities in accordance with Article 62 of this proclamation;

9. “Xafiiska” waxaa loola jeedaa xafiiska horumarinta magalooyinka iyo Dhismaha ee lagu aasaasay qodobhoosaadka (4) ee Qodobka 4 ee Bayaanka Dib Loo Habeeyay Ee Bayaaminta, Awoodaha Iyo Waajibaadka Xafiisyada Fulinta ee Tirsigiisu yahay 185/2012.

10. “Deegaan” waxaa loola jeedaa Deegaanka Soomaalida.

3. Isticmaalka Jinsiga

Qodobada bayaanka ee ka hadlaya jinsiga labka waxa sido kale loo isticmalaya kuwa dhidiga ah.

4. Xadka fulineed

Bayaankan waxaa lagu dabaqayaa dhamaan noocyada iyo heerarka magaalo ee hab waafaqsan bayaankan laga aasaasayo deegaanka soomaalida dhexdiisa.

- Kh) Magaalo leh Dawlad Hoosaad.
- d) Magaalo Soo koraysa.

5. የከተሞች ፈርጆችና ደረጃዎች

1. በሱማሌ ክልላዊ መንግሥት የሚገኙ ከተሞች አስተዳደራዊ አደረጃጀታቸውን፣ አመራራቸውንና የተጠያቂነት ሁኔታ ለመወሰን ይቻል ዘንድ የክልሉ ከተሞች ከዚህ በታች በተመለከቱት ስድስት ዋና ዋና ፈርጆች ተመድቦታል፡-

ለ/ የፈርጅ አንድ የከተማ አስተዳደር፤

2. የክልሉ ከተሞች የከተማነት ደረጃ በየፈርጆች ስለመመድባና ከአንድ ፈርጅ ወደ ሌላ ፈርጅ የማሸጋገሪያ መስፈርቶች በክልሉ ሥራ አስፈጻሚ ምክር ቤት በሚወጣው ደንብ ይወሰናል፡፡

9. “Bureau” means the urban development and constriction Bureau established under sub-article 4 of article 4 of proclamation no 185/2012, A Proclamation to Provide For The Definition Of The Powers And Duties Of The Executive Orangs Of Somali Regional State.

10. “Region” means the Somali Region.

3. Gender Expression

Any stipulated case with masculine gender in this proclamation also includes the feminine gender.

4. Scope of Applicability

This proclamation shall apply to all categories city administration established and to be established in accordance with this proclamation in regional state.

PART TWO

Categorization, Organization, Accountability and Geographical Boundary of Cities

5. Classification of Cities in Categories

1. The Cities of Somali Regional State are classified with six principal categories stipulated herein under to be able to determine the administrative organization, leadership and accountability thereof:

- a) Regiopolis City Administration,
- b) Category One City Administration,
- c) Category Two City Administration
- d) Category Three Cities,
- e) The municipality cities
- f) The emerging cities

2. The regional government council shall determine with regulation criteria for each level of urban hood and procedure for change of category.

6. U tirsanaanta Magaalooyinka

 - b) Maamulka Magaalada rigiopolis, Maamulka magaalada derajada koowaad, labaad iyo sadexaad waxay hoostegaan Golaha hawlfulinta ee Dawlada deegaanka Soomaalida,
 - t) Maamulada magaalooyinka soo koraya iyo maamulada magaalooyinka leh dawlad hoosaad waxay hoostegayaan Maamulka degmada ay ka tirsanyihiin.
2. Iyadoo ay sideeda tahay arrimaha lagu xeeriyay Qodob hoosaadka (1) ee Qodobkan, dhamaan derajooyinka kala duwan ee maamulada magaalooyinku waxay dhinaca xirfada iyo farsamada hoostegayaan Xafiiska horumarinta magaalooyinka iyo dhismaha.

7. Xadeynta xuduuda Magaaloyinka

Dhamaan Derajooyinka Maamul-magaalooyinka ee laga aasaaso degaanku waxay yeelanayaan xuduud qeexan hab waafaqsan xeernidaameedka uu soo saaro Golaha hawlfulintu.

8. Jiritaanka sharciyeed ee Maamulada magaalooyinka

Hab waafaqsan qodobka 5^{aad} ee bayaankan iyo xeer-nidaameedka uu golaha hawl fulinta deegaanku soo saaro magaalooyinka hela jiritaan sharciyeed oo ismaamul magaalo oo awood u siinaya in ay hay'adaha lacageed ee dalka ay ka daysadaan, galaan heshiisyo kala duwan, mulkiyaan hanti, in ay wax dacweeyaan lana dacweeyo islamarkaana ay ismaamulaan.

6. ሰለተጠሪነት

- 1. የከተማ አስተዳደሮች ተጠሪነት ለከተማዋ ነዋሪ ህዝብ ሆኖ፦
 - ሀ/ የሪጂዮ ፓሊቲን ከተማ አስተዳደር በፈርጅ አንድ፣ በፈርጅ ሁለት እና በፈርጅ ሶስት የተመደቡ የከተማ አስተዳደሮች ተጠሪነት ለክልሉ ስራ አስፈጻሚ ምክር ቤት ይሆናል፤
 - ለ/ የማዘጋጃ-ቤትና ታዳጊ ከተማናት የተመደቡ የከተማ አስተዳደሮች ተጠሪነት ለየታቀፉበት ወረዳ አስተዳደር ይሆናል።
- 2. በዚህ አዋጅ አንቀጽ 1 የተደነገገው እንደተጠበቀ ሆኖ በሁሉም የከተማነት ፈርጅ የተመደቡ ከተሞች ሙያዊ እና ቴክኒካዊ ተጠሪነት ለክልሉ የከተማ ልማትና ኮንስትራክሽን ቢሮ ይሆናል።

7. ሰለ ከተሞች መልክ-ምድራዊ ወሰን

በዚህ አዋጅ መሠረት በብሔራዊ ክልሉ የተቋቋመ ማንኛውም ከተማ የራሱ የሆነ መልክ-ምድራዊ ወሰን ይኖረዋል፤ የከተሞች መልክ-ምድራዊ ወሰን አካላለልን በተመለከተ የክልሉ መስተዳድር ምክር ቤት ይህንን አዋጅ መሠረት አድርጎ ደንብ ሊያወጣ ይችላል።

- 8. የከተማ አስተዳደሮች ሕጋዊ ሰውነት ሰለማገኘት
 በዚህ አዋጅ አንቀጽ 5 እና በክልሉ ካብኔ በሚያወጣው ደንብ መሠረት በክልሉ ውስጥ የተቋቋመና የተደራጀ ማናቸውም የከተማ አስተዳደር የራሱ መጠሪያ ስምና ሕጋዊ ሰውነት ያለው ሲሆን ከሃገር ውስጥ የገንዘብ ምንጮች የመበደር ሥልጣንን ጨምሮ ማናቸውንም አይነት ውል የመዋዋል፣ የንብረት ባለቤት የመሆንና የማስተዳደር እንዲሁም በሕግ መሠረት የመከሰስና የመከሰስ ችሎታና መብቶች ይኖሩታል።

6. Accountability

- 1. The accountability of urban centers shall be to the urban center resident people based on the level of the power hierarchy, and
 - a) The *Regiopolis* city administrations, category one, category two and category three city administrations shall be accountable to the Regional Government Administrative Council;
 - b) The Municipality and Emerging towns shall be accountable to the woreda administration therein;
- 2. Notwithstanding the provisions stipulated under sub-article /1/ of this article, various sectors of the *Regiopolis* city administrations shall have professional accountability, as deemed appropriate, to their respective sectors established at the level of the region;

7. Geographical Boundaries of Urban Centers

All urban administrations established within the region shall have defined geographical boundary to be determined regulation to be issued by the Executive council.

PART THREE

CITY ADMINISTRATIONS IN GENERAL

8. The Juridical Personality of City Administrations

Any city administration established and organized in the region in accordance with article 5 of this proclamation and regulations to be issued by the Executive council shall have its own legal personality and a calling-name, and shall there by have the legal capacity to enter into any contracts including the power to borrow from local financial sources, to own and manage property as well as to sue and be sued in accordance with law.

10. Ujeedooyinka maamulada magaalooyinka

Maamulada magaalooyinku waxay yeelanayaan ujeedooyinkan hoos ku cad;

1. Inay abuuraan maamul karti iyo cadcaddaan leh,aminsan la xisaabtanka dadwaynaha islamarkaana xoojiya dhismaha dimuqraadiyadeed iyo hirgalinta maamulka suuban
2. Inay abuuraan hannaan sahlaaya horumarka magaalada oo ku fadhiya nidaamka kobcinta awooda wax soo saarka
3. Inay fidiyaan islamarkaana xaqiijiyo iyado laga duulayo baahida bulshada magaalada adeegyada kaabayaasha dhaqaalaha
4. Ka qayb qaadashada dadaalka loogu jiro horumarka dhaqaale islamarkaana loo abuurto jawi sahlaaya in ay hantiilayaasha gaarku ay maalgashadaan warshadaha yar yare e ahmiyada u leh horumarka magaalada iyo kobcinta xaalada dhaqaale ee bulshada si loo dhimo saboolnimada baahsan ee ka jirta deegaanka.

City Administrations shall in all their activities observe the principles indicated herein under

1. The principle of democratic leadership and good governance;
2. The principle of development;
3. The principle of self-sufficient in revenue;
4. The principle of observing Regional and Federal laws
5. The principle of integration, and cooperation
6. The principle of integration

10. Objectives

The established city administrations, in accordance with this proclamation, shall have the following principal objectives:

1. Create an environment where the rule of law is respected, the reliable peace is guaranteed, and strengthens the building of democracy and the prevalence of good governance;
2. Create a suitable condition for the urban development to guide and accelerate the rural and agricultural-centered development;
3. Provide or cause to provide the efficient and adequate provision of appropriate infrastructure and other services in response to the needs of city residents and service seekers;
4. Contribute constructive roles towards poverty reduction, the improvement of the life of the resident population and development of the region by creating a suitable environment for private sector particularly to the micro and small enterprises through promoting rapid and sustainable urban development on the basis of the principles of partnership, cooperation and coordination,
5. Capacitate cities, to be free from environmental pollution, to conserve natural resources and utilize input appropriately;
6. Following the principle of participation, to ensure that the resident participate actively in political, administration, development and the provision of services;

11. Powers and Duties of City Administrations

Every City with the statues of City Administration shall have the following powers and duties

1. A city administration established with this proclamation in accordance with the constitution, shall issue urban ordinance, directives and polices nclude powers rendered by the constitution and other particular laws that are not plainly prohibited with regard to such laws.
2. determine and cause to execute the shared vision, objectives and functions of cities with the view to bringing integrated social and economic development;
3. To design plan of actions and execute that help to direct and support to the urban development;
4. Establish, administer, reorganize or cause to abolish the executive organs of the city;
5. Draw up, approve and administer the budget of the city;
6. Administer and develop, in accordance with law, the lands and natural resources found within the boundary of the city;
7. Levy, determine service charges, collect, use and as deemed appropriate, leave taxes as well as imposed penalties with the appropriate income tax and tax administration laws, regulations and directives on financial matters which fall under the jurisdiction of the city;

13. Determine, introduce the collection of taxes and service charges in accordance with the law.

14. Design, approve and implement the city plan by expropriating private property for public pursue subject to payment in advance of compensation commensurate to the value of the property;

15. Engaging in the construction of intercity roads, the provision of road lights, construction of drainages and sewerages ; Setting up of solid waste disposal systems;

16. To expand, facilitate the expansion, direct and administer primary and comprehensive secondary schools including kindergartens, health centers and other social service rendering institutions in the city;

17. Regulate food and beverages and environmental sanitation within the boundary of the city on the basic standards issued by the authorized body with law

- i) appoint an external/authorized auditors to ascertain whether the finance and property of the city administration has been utilized for purposes designated by law or not, and give the proper decision based on the report it has been presented thereof;
- j) organize /establish other extective organs of the city.

15. working Procedure of the city Council

1. The council shall hold its regular meeting once in three months, but an extraordinary meeting may be called by the house speaker or by when the request of one-third of the council members.
2. The presence of 2/3 of the council members shall constitute quorum;

16. Dissolution of the City Council

- 1. Any city council shall not be dissolved without the prior discussion and decision of the concerned city dweller;
- 2. Notwithstanding to the stipulation under sub- article /1/ of this article, where the council of the regional government understands that a grave act has been committed which harms the public interest or that endangers the constitutional order, it shall have the authority to suspend the city council temporarily and investigate the matter. In such a time, it shall designate a provisional administration to run the city affairs.
- 3. The Regional council shall give a final decision on the basis of the findings concluded by the council of the regional government in accordance with the stipulation of sub-article /2/ of this article.
- 4. Where the given decision is found to be leading to the extent of dissolution of the existing city council, election for a new city council shall be held and completed within a period not beyond six months commencing from the day on which decision of suspension measure is made.

17. The House Speaker of the City Council

- 1. The house speaker of the city council shall be elected from among the council members and be accountable to the council.
- 2. The term of the house speaker is the same as the term of the council

- 3. Represents the council in all its dealings with third parties;
- 4. Enforces the disciplinary decisions and takes corrective measures that the council may take against its members;
- 5. Prepares work plan for the capacity building of the council members, executes this in cooperation with pertinent organs;
- 6. Creates friendly relationship with sister cities in and outside the country, makes to be done exchange of experiences;
- 7. Carries out other related duties entrusted to him by the council.

19. The Deputy House Speaker

The deputy house speaker of the city council being accountable to the speaker and to the council shall;

- 1. Acts on behalf of the house speaker in his absence or when he is unable to perform his duties.
- 2. Carries out tasks specifically entrusted to him by the speaker;

20. The Secretariat of the Council

- 1. The city council shall have its own office so as to discharge the responsibilities entrusted to it by this proclamation;

25. Meeting Procedure of the Mayor's Committee

- 1. The mayor's committee shall hold its regular meetings once every fifteen days; however, urgent meetings may be called through the initiative of the mayor or by the request of one-third of the committee members when necessary.
- 2. The presence of more than half of the committee members shall constitute a quorum.
- 3. Decisions of the committee shall be taken by a majority vote of those who constitute the quorum, provided that in case of tie, the mayor shall have a decisive vote.

Every city administration shall have its own general manager of city services and where deemed necessary - deputy managers.

27. Appointment of the General Manager of the City Services

3. Ensure the implementation of council decisions related with municipal service as well .as the observance government laws, policies and service delivery standards ;
4. Form a management team consisting of heads of municipal service departments or those accountable to him for facilitation information sharing, flourishing of performance, evaluation and service delivering.
5. shall have head of the municipal service sector , agencies and offices appointed by the mayor;
6. Recruits, give promotion, determine the salary and allowance suspends from work or dismisses subordinate officials and employees in municipal service delivery under him in accordance with law;
7. Make recommendations, to the Mayor and for the municipal city service delivering agencies for the establishment of municipal city service delivering bodies, internal organization and alternative means of delivering different services; implement same when decided.

12. play a key role in enabling the city council and mayor’s committee efforts for improving the financial condition and future development needs of the city administration;

13. Conducts a study on policy matters on circumstances of improving the revenue of the city, keeping the residents people security, and for the provision of integrated services that build the good governance and by notifying the result to the mayor;

14. Causes good and friendly ties to be maintained among the community so as to strengthen a tie which is based on a healthy work and supportive relationship;

15. Presents to the mayor recommendations on revision the internal organization of organs of municipal services and implements it when approved;

16. Receives, examines petitions and complains presented by the city resident people in case of service delivery problem and reacts thereon without delay;

17. Prepare and submit to the Mayor and the committee, the budget and work plan of the budget year of municipality service delivering bodies; implement same upon approval.

18. Carries other related duties entrusted to him by the mayor and the City Executive committee

29. **Deputy Manager of City Services**
 1. The deputy manager of city services is appointed by the mayor;
 2. The *Rigopoulos* and Category One city Administrations may have more than one deputy manager;
 3. The deputy manager of city services shall be accountable to the general manager of the city.

30. **Powers and Duties of the Deputy Manager**
 Deputy Manager shall have the following power and functions:-

1. Acts on behalf of the general manager in his absence or in times and conditions when he cannot carry out his duties.
2. Carries out duties specifically entrusted to him by the manager;

31. **Establishment and powers and duties of Sectorial Offices of the Cities**
 The sectorial offices and different services delivering institutions shall be established in accordance with the grade of the city that may be accountable to the mayor or the city council. to be decided by the regulation to be issued by the Regional Executive Council.

PART FOUR
THE MUNICIPAL TOWNS IN
GENERAL

32. **Being Organized as a Municipality Town**
 1. Any urban centers in the region that have not been able to qualify the criteria for the establishment of category three city administration cities' shall be organized and incorporated as a municipal town in accordance with a regulation following this proclamation.

2. 2. Any organized municipal town shall, in accordance with the provision stipulated under sub-article /1/ of this Article, have its own legal personality and a calling-name and shall by virtue of that name have the capacity to own and administer property, enter in to contracts as well as shall have sue and be sued ability and rights in accordance with law.

33. Objectives

The city administrations objectives stipulated under Article 11 of this proclamation shall be also similarly applicable for the municipality towns.

34. Working Principles that Municipal Towns Should Follow

Working principles provided under Article 9 of this proclamation for city administrations shall apply equally to the municipal towns in each level.

35. Powers and Duties of the Municipal Towns

1. To administer and develop, in accordance with law, the lands and natural resources found within the boundary of the town;
2. To levy, determine service charges, collect, use and as deemed appropriate, leave taxes as well as imposed penalties with the appropriate income tax and tax administration laws, regulations and directives on financial matters which fall under the jurisdiction of the town;
3. in accordance with law determine service charge receivable from different services and other incomes;
4. Execute and implement the master plan of the town subject to payment in advance of compensation commensurate to the value of the expropriated property.

- 13. provide and ensure the development of basic infrusture service such as provisions of the construction of intercity roads, the provision of road lights, Setting up of solid waste disposal systems; parking, Organizing recreation centers and gardens, Engaging in, maintenace of drainages and sewerages in the town as well as regulate all measures for ensuring environmental sanitation in the town.

- 20. In accordance with citizens charter give performance indicators to provisions of municipal service.
- 21. Cause the expansion and ensure the adequacy of the supply of waters, electric, telephone and transport services in the town and also the accessibility to the beneficiary society fairly;

PART FIVE

The Emerging Towns in General

36. Acquiring Recognition as

Emerging town

Any urban centers in the region that have not been able to qualify the criteria for the establishment of municipal town shall be organized and incorporated as Emerging town in accordance with a regulation to be issued by the regional executive council.

37. Working Principles and

Objectives of emerging towns

The Working principles and Objectives provided under Article 9 and 10 of this proclamation for city administrations shall apply as deemed appropriate to the emerging towns in each level.

38. Powers and Duties of the emerging Towns

- 1. Without prejudice to the powers vested in the kebele administrations by other laws, the emerging Towns in accordance with this proclamation:-
 - a) Directs and coordinates their local social and economic development activities and mobilizes the resident population for development,
 - b) Creates conducive environment to whom constructing houses and give the necessary support;
 - c) Follows up closely and supervises the legality of constructions being built with the geographical boundary in their organizational localities;
 - d) Collects revenues that shall be rendered in isolation with kind based on the determination of regulation to be issued with the regional bureau;
 - e) Works in cooperation with appropriate bodies to keep their local peace and insure the resident population security;
 - f) Encourages the resident community to protect and care widely the local natural resources;
 - g) Carries out other related duties rendered by each embracing woreda administrations.
- 2. The emerging towns shall be accountable to the appropriate woreda administrations or other body specifically entrusted.

PART SIX

The Sub-Cities in General

39. Being Organized as a Sub-City

- 1. Sub-cities shall be organized in the *Regiopolis* City Administration cities of the region and as an appropriate in the cities that are incorporated under category one City Administration.
- 2. In accordance with the provision stipulated under sub-article /1/ of this article, each sub-city has its own legality and calling-name, enter in to contracts, own property and administer as well as it shall be established having the ability of sue and be sued.

40. Organs of a Sub-City

- 1. Every sub-city shall have the following organs:
 - a) A chief executive officer and, as deemed necessary, deputy chief executive officer,
 - b) A sub-city administration executive committee,
 - c) A municipal services manager and, as deemed necessary, vice manager,
 - d) Other executive offices.
- 2. Sub-City has no its own council

41. Designation and Accountability of the Sub-City Chief Executive Officer

- 1. The chief executive officer of the sub-city shall be appointed by the city mayor;
- 2. The chief executive officer of the sub-city shall be accountable to the sub-city administration executive committee and the mayor of the city.

42. Powers and Duties of the Sub-City Chief Executive Officer

- 1. The sub-city chief executive officer shall be the chief administrator of the sub-city, chair person of the administration executive committee.
- 2. Without prejudice to the generality of the stipulated provision under sub-article /1/ of this article, the sub-city chief executive officer shall have the following powers and duties herein under:
 - a). Submit to the city Mayor and mayors' committee for the appointment of the; sub-city municipal service manager and other members as deemed necessary other managers;

- e).Prepares periodic activity performance reports and present to the sub-city resident population, and submit to the city mayor and mayors’ committee to be complied and presented to the city council;
- f). Closely follows up and supervises the day to-day activity of the general management of the sub-city, evaluates its implementation and takes appropriate corrective measures;
- g). Organizes and creates suitable conditions for public forums where the overall activity reports of the sub-city administration would be presented periodically to the public openly, and public opinions would be gathered thereby;
- h). Carries out other related duties given by the city administration.

43. The Deputy Executive Officer of the Sub-City

The deputy executive officer of the sub-city being accountable to the chief executive officer and the sub-city council shall:

1. Carry out activities - given in isolation by the chief executive officer;

2. Wuxuu qabtaa hawlaha kale ee uu u xilsaaro gudoomiyahu.

The stipulated provisions of article 24, 25, and 26 of the mayor committee in this proclamation, seeing as their appropriateness, shall be applied on the sub-cities.

45. Appointment, Removal and Accountability of the Sub-City Municipal Service Manager

1. The city service manager of the sub-city shall be proposed by the sub-city chief executive officer and the sub-city's executive committee and appointed by the mayor of the city.

2. The city service manager of the sub-city, being accountable to the sub-city chief executive officer and concomitantly to the manager of the city and executive organ of the sub-city.

3. In accordance with the provisions stipulated under sub-article /1/ of this article, appointments of the manager shall be based on the professional competence and best qualification with regard to city management and with accumulated experience.

4. In case of loss of confidence, the sub-city administration executive committee may remove the sub-city municipal service manager from his position setting forth detailed reasons in its power of removal letter.

46. Powers and Duties of the General Manager of the Municipality Services

1. Directs over and coordinates and encourages works, of municipal services,

- 4. Prepares the sector's services delivery performace reports, and presents to the Chief Executive Officer and to the executive body of the sub-city;
- 5. Causes a fair development and service delivery system is established in the sub-city which is full of transparency, participative of the resident population and beneficiary to them, and makes the system to be functional;
- 6. Carries out other related duties given by the sub-city and the city administration.
- 7. Administer employees of the municipality of the sub-city in accordance with the law.

47. The Vice Manager of the Sub-City

The sub-city municipality services vice manager shall:

- 1. Carry out duties given by, in isolation, the sub-city manager;
- 2. Act replacing the sub-city manager in his absence or when in times and conditions he cannot carry out his duties.

48. Administration Office of the Sub-City

Sub-cities which are established in accordance with this proclamation shall have their own offices. The particulars shall be determined by a directive to be issued by the bureau for the execution of this proclamation.

49. Nidaamka maamul iyo qaab dhismeed ee Magaalo Hoosaadka

1. Urban centers of the regional state organized as emerging town until they qualify for the criteria set for the status of medium level city administration may not have city council.
2. The type and management system to be applied in emerging town shall be determined by a regulation to be issued by the Executive council.

PART SEVEN

The kebeles

50. Being Organized as a kebele

1. It is hereby established kebeles Administration in cities that are the lowest administrative setup of cities.
2. the duties, organization and working procedure of the kebeles in the city shall be determined by the city Council;
3. The organized kebeles in the city shall be accountable to the city administration and the embracing city council.
4. Kebeles in the city shall have their own elected councils. details shall be determined by law;
5. The kebele council shall submit its suggestions and plans and programs concerning their kebeles to the city administration. as well as carry out duties given to it under city ordinance to be issued by the city council;
6. Kebeles in the city shall have social courts which its judges shall be appointed by the kebele council. its establishment, powers and duties shall be determined by law;

51. Xidhiidhka Dawliga ah

PART EIGHT

RELATIONS

51. Relations with the Government

1. The city administration shall have direct relation with all public institutions, non governmental organizations and all government administrations operating in the Region. Have legal power to enter into agreements with its own name , participate in Investment activities subject to the power given under this proclamation.
2. The city council shall be accountable to its electorate.
3. it is essential that city administration is required to organize Regular forums for the urban residents to discuss and express their views on such matters as budget, plan of action, work performance, finance-related reports and other items of similar nature.
4. The city council during their regular sessions may invite some known individuals and intellectuals to participate, and contribute in forming sub-city and for the city development being carried out in kebeles, participate in the council meetings with out the voting right.
5. without prejudice with the provisions of the constitution councils established in kebeles within the city shall be Without prejudice to the provision stipulated under constitution kebeles council organized within the limit of the city administration shall be accountable to the electorate and the embracing city council.
6. The boundary delimitation of urban centers shall be determined by the regional executive council upon recommendation of the Bureau.

52. Xidhiidhka Dadwaynaha

1. Magaaladu wuxuu waajibu kasaaran yahay in ay doortaan gole maamul oo u adeega, waxna ka qabata dhibaatooyinka maamul, horumar iyo adeeg xumo ee ka haysta maamulka magaalada.

3. Waxaa waajib sharci ahi ka saaran yahay golaha magaalada in ay la socodsiiyaan bulshada magaalada, hayadaha aan dawliga ahayn iyo hantiilayaasha gaar ka ah dhamaan go'aamada iyo nidaamka loo fuliyo mashaariicaha dawlada bulshada uqabanayso maadaama loo baahan yahay in ay door wayn ka qaataan meel marinta mashaariicaha.

3. the city council have legal responsibilities to inform and make known to the Urban residents, non governmental organizations and private investors all decisions and as to how implemented projects designed for public by the government, as their active participation is curial for the execution of this projects.

53. Urban- Rural Relations

1. In order to strengthen urban-rural economic interaction, the cities may establish joint committee with the adjoining district to work cooperatively on issues of mutual interest.
2. Boundary dispute arising between the cities and the ad-joining rural kebele shall be settled amicably between the city and concerned rural kebele. Failing such amicable settlement, the decision of regional executive council shall be final

54. How the Regional Government Assists the Cities

1. Without prejudice to the grant regional government may give for the implementation of specific projects, the regional government shall provides development assistance to the cities basis of competitiveness and equity.

- 4. Where the the existing city council is dissolved in accordance with sub-article 3 of this Article. ution of, , the government may Designate provisional Administration and cause to be held election for a new city council within a period not beyond six months.

- 1. There shall be established Woreda courts in Regiopolis City Administration, Category One, two and three City Administrations shall have Woreda Court.

1. A social court, shall be established in urban centers organized as Municipal city and emerging town.
2. Proclamation no 102/2003 issued for establishment of Social courts in kebeles of Somali Regional State shall be applicable social courts at Municipal city and emerging town.

PART TEN

THE URBAN PLAN

59. The Preparation and Implementation of Urban Plan

1. Any urban administration shall, as far as its capacity allows, have the authority to prepare, cause to be prepared, approve, amend and implement a city plan.
2. The cities shall observe the fundamental principles, guidelines and standards of plan preparation of the regional state and the Federal government in the process of plan preparation. Its particulars shall be decided by the regulation to be issued.
3. The urban administration up on exercising the power under sub-article 1 hereof, may consult with the Bureau so as to ensure that Urban Plan complies with standards set for and rules and laws applicable .

60. The Urban Plan Approval

1. The city council of *Regiopolis* city administration and category one, Two and three level city administrations shall be submitted the urban plan and causes for approval, and causes the implementation commencing from its approval.
2. The power to approve the plan of the municipal towns and Emerging towns shall be the concerned Wereda council.

PART ELEVEN

ASSOCIATION OF CITIES

61. Establishment of the Associations

1. City administrations and/or municipality towns in the region may establish associations of their own and actively participate in the operation thereof.
2. The association shall be registered by the appropriate government body and acquire legal personality.
3. The structural and manner of operation of the association shall be determined by its memorandum of association and internal regulation.
4. The City administrations and/or municipality towns up on exercising the power under sub-article 1 hereof, may consult with the Bureau.

62. Power and Functions of the Associations of the Cities

The association of cities and/or towns, without prejudice to the power and functions provided under its memorandum of association and internal regulation; shall have the following power and functions;

- e) Carry out other activities that would enhance the developments of cities and/or towns in the region.

PART TWELVE

63. Power and Duties of the Bureau

Without prejudice to the powers and duties given to the under proclamation no 185/2019 proclamation to define the organization, powers and duties of Executive organs of Somali Regional State and by other laws, the Bureau shall have the following specific powers and duties:

1. Assist closely to promote the overall capacity of urban centers of the region through training, awareness raising, experience sharing and such other programs and render other professional and technical supports;
2. Advice the Regional State Government on matters relating to cities;
3. Initiate and draft proclamations and regulations concerning to urban affairs, and submit for approval,
4. Ensure that the development plan of the city administration and the municipalities conform with the overall development need of the region;

- 6. Ensure that the development plan of the city administration and the municipalities conform with the overall development need of the region;
- 7. Entertain and decide on the request of residents to obtain legal personality of being a city,
- 8. Reviews the request of the cities for promotion to the next grade and submit its proposal to the regional executive council; implements same upon approval,
- 9. Support cities of the regional state to create and strengthen relationship with other cities in the country and outside the country,
- 10. Initiate advanced working practices and Ensure the obedience of the regional cities to the issued policies, laws and standards፤
- 11. Prepare periodical reports focusing on the activities of the city administrations and submit to the pertinent regional government body.

PART THIRTEEN

URBAN FINANCE AND BUDGET

ADMINISTRATION

64. Fiscal Year

The fiscal year of the regional state shall be the fiscal year of the city administration or of the municipal town

65. Budget

- 1. The city administration shall prepare next annual budget before 30th of Ginboot every year.

 - a) Main objectives, goals and tasks to be implemented;
 - b) The proposal capital and recurrent expenditure, and;
 - c) The anticipated revenue and its source;
- 5. Any city administration shall have a responsibility to present a complete report at the end of the fiscal year confirming that, if there is, block grant received from the regional government has been utilized for the planned purpose
- 6. Any city included under category mancipal city and emerging towns the budget is assigned in formula including the subsidy budget if there through the pertinent wereda administration, and shall have a responsibility to submit a complete report at the end of the fiscal year by ensuring this budget has been executed for the planned service.

66. Sources of Income

- 1. Urbans shall have the following sources of income:-
 - a) Tax collected from service delivery, tax and service payment;
 - b) The budget given by the Regional Government through formula.

2. The executive council of the regional government may issue regulation following to this proclamation with regard to levying urban service charges and taxes.

3. Prior to the implementation of the loan of the cities in accordance with sub-article (1)c of this article, its importance shall be decided by Executive Council of Regional State.

4. The cities may borrow money from the federal or regional governments as well as from the legally recognized financial institutions. The loan obtained in such a way shall be allocated only for the expenses the of capital projects.

5. Details of the condition of loan and their payments shall be decided by the regulation to be issued.

67. Management and Administration of finance

1. Every city administration shall have the power and responsibility to organize and manage its own finance.

2. The city shall open and operate a bank account in its name to deposit the revenues it collects under various items as well as charges it receives, in accordance with this proclamation and other laws; it shall also close the account when it finds it necessary.

3. The regional administration council issues the finance administration regulation that the city administrations or municipality cities should work.

68. keeping and auditing books of accounts

1. Every city administration shall maintain accurate and complete books of accounts.

- 3.The city council of every city shall appoint an accredited external auditor every year that shall evaluate the performance of the city administration, check whether or not the city funds have been properly utilized and assures the accurateness and completeness of reports presented by the executive bodies.

PART FOURTEEN

69. the Human Resource Management

- 1. The employment, promotion, downgrading, and termination of civil service of every city administration shall be carry out in in accordance with Regional State civil service laws.
- 2. every city administration shall have the power to employ its own permanent and temporary employees, to assign, promote, and where they are found in guilty as deemed necessary, to take the disciplinary measures (including to firing).
- 3. In accordance with the provision stipulated under sub-article /2/ of this article, the appointment of city service managers, employment and promotion system of employees shall be undertaken based on the candidate appointee's or employee's personal merit and fitness of the work

PART FIFTEEN

MISCELLANEOUS PROVISIONS

70. Exercising New Practices

- 1. A city administration established at any level shall, in consultation with the bureau, have a right to periodically innovate and experiment new ways to organize itself, exercise its powers or perform city functions.

72. Qodobada kala guurka

1. Markasta oo ay xaaladu lagama maar maan ka dhigto golaha hawlfulinta ee deegaanku wuxuu samayn karaa in qodobada bayaankan loo fuliyo wajiyo.
2. Dawlada deegaanku ama maamulada degmooyinku waxay ku wareejin magaalada ay khusayso dhamaan shaqaallihii iyo hantidii ay maamuliyeen dawlada hoose ka hor intaan bayaankan la soo saarin.

73. Waajibaadka Gacansiinta

Cidkasta waxaa waajib ka saaranyahay marka laga codsado dhaqangalinta qodobada Bayaankan.

74. Shuruucda aan Dhaqan galka lahayn

1. Waxaa bayaankan lagu buriyay bayaanka bayaaminta asaaska, awoodaha iyo waajibaadka magaalooyinka dawlada deegaanka soomaalida bayaan tirsi: 90/2003.
2. Bayaan, xeer, awaamiir iyo hab dhaqameed shaqo oo kasta oo ka hor imanaya qodobada bayaankan ma laha fulitaan sharciyeed.

1. አስገዳጅ ሆኖ ስገኝ የክልሉ መንግሥት መስተዳደር ምክር ቤት ይዚህ አዋጅ ድንጋጌዎችን ምዕራፍ በምዕራፍ ሥራ ላይ ሊያውል ይችላል።
2. የክልሉ መንግሥት ወይም የወረዳ አስተዳደሮች ይህን አዋጅ ከማውጣቱ በፊት በነሱ ስር የነበሩ በማዘጋጀት ስር ይተዳድር የነበሩ ሠራተኞችና ሀብት በአዲስ ለተዳራጀው ከተማ አስተዳደር ያስራከባሉ/ያስተላለፋሉ።

73. የመተባበር ግዴታ

ማንኛውም አካል ይህን አዋጅ ሥራ ላይ ለማዋል የመተባበር ግዴታ አለበት።

74. ተፈጻሚነት ስለማይኖራቸው ሕጎች

1. የሶማሌ ክልላዊ መንግሥት ከተሞች ማቋቋሚያ፣ ማደራጃና ሥልጣንና ተግባራት መወሰኛ አዋጅ ቁጥር 90/2003 ዓ.ም በዚህ አዋጅ ተሸረጠ።፤
2. ከዚህ አዋጅ ጋር የሚቃረን ማንኛውም ሕግ፣ ደንብ፣ መመሪያ ወይም የተለመደ አሠራር በዚህ አዋጅ ውስጥ በተሸፈኑት ጉዳዮች ላይ ተፈጻሚነት አይኖረውም።

2. The bureau may, commencing from setting a time limit for the experimentation stated under sub-article /1/ of this article, conduct periodic evaluation to ensure its efficacy.

71. Provisional administrations

until in accordance with the law the election of city councils are to be conducted and organized in the urban centers the regional executive council may temporarily designate a provisional administration to run the city affairs. Details on the matter shall be determined by the regulation issued by the regional executive council.

72. Transitory Provisions

1. The Regional Executive Council may determine for the implementation of the Proclamation by phase.
2. The Regional State Government shall the rights and duties acquired prior to this proclamation by the city administration shall be transferred to the urban local governments that acquired legal personality in accordance with this Proclamation.

73. Duty to Cooperate

Any organ shall have a duty to cooperate for the implementation of this proclamation.

74. Repealed and Inapplicable Laws

1. The Somali Regional State Urban Centers Establishment, Organization and Determination of their Powers and Duties Proclamation No.90/2003 is hereby repealed by this proclamation.
2. Any Proclamation, regulation, directive or customary practice inconsistent with this proclamation shall not be applicable on matters provided in this proclamation;
