2. Amendment

The Somali Regional State Office of the Auditor General Re-Establishment Proclamation No.182/2019 is hereby amended by this proclamation as follows:

- The following new Article. 6 is added to the proclamation and, to that effect, the former Article 6 of the proclamation is shifted to Article 7 hereof,

6. Organization of the Office

The office shall have the following organs:

- An Auditor General:
- A Deputy Auditor General:
- Audit Directors:
- Auditors at various levels; and
- Other necessary professionals and supporting staff.

2. Sub Article .17 of Article 6 of the proclamation is hereby deleted and replaced by the following new sub Article 17.

17/. Charge fees, which to be determined by a regulation issued pursuant to this proclamation, while issuing and renewing certificate of competence.

- The following new Article. 8 is added to the proclamation and, to this effect, Article 8 of the proclamation is shifted to Article. 9 hereof,

There shall be one Deputy Auditor General who shall assist the Auditor General and shall be responsible for activities of the office upon the absence of the Auditor General who shall be appointed by the state council upon recommendation by the President of The Regional State President;</p> <p>2. The Deputy Auditor General shall be accountable to the Auditor General.</p> <p>3. The provisions under Article 8,9,10 and 11 of the proclamation applicable to the Auditor General shall be also mutandis –mutandis applicable to the Deputy Auditor General.</p> <p>4. Article 12 of the proclamation is hereby deleted and replaced by the following new Article 12.</p> <p>12. <u>Following in a Vacant Position</u></p> <p>1. The Deputy Auditor-General performs in the place of the Auditor-General of the Region where the latter gets removed from responsibility, discharged from work for reasons specified in under Article 11 of this proclamation or becomes deceased,</p> <p>2. Where the posts of the Auditor General and the Deputy Auditor General of the Region are simultaneously vacant, the Speaker of the State Council may temporarily assign as an acting Auditor General among the Audit directors for a maximum of three months.</p>

14. Powers and Duties of the Deputy Auditor General

The Deputy Auditor General shall have the following Powers and duties:

1. shall Assist the Auditor General in planning organizing and directing, coordinating and controlling the Audit activities of the Office;
2. shall carryout duties of the Auditor General in his absence except signing of the audit report on the consolidated account of the government, annual performance report and special report of the office to be presented for the State Council;
3. Shall carryout other duties assigned to him by the Auditor General.

3. Effective Date

This Proclamation shall enter into force as of the day approved by State Council.
